5. All proposals will be evaluated as per evaluation criteria of prequalification by the committee constituted by CBF.
6. Bid validity period will be 10 days.
7. The proposals /rates must reach the office of the undersigned by 05.07.2021 upto 2:00 pm which will be opened on same day at 2:30 pm as per PPRA rules.
